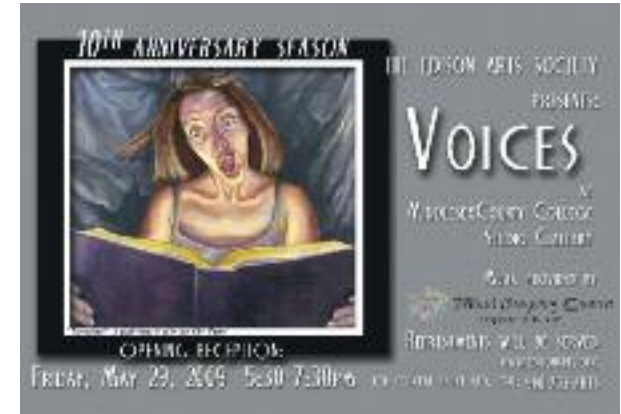


# Prospectus

In addition to independent curatorial and jurying activities, she has served as a General Operating Support grant panelist for the New Jersey State Council on the Arts and as a General Operating Support Field Reviewer for the Institute of Museum & Library Services in Washington, DC. She holds a Bachelor of Arts degrees in both Art and Psychology, with additional training in 20th Century American Folk Art from the Folk Art Institute, New York City, and in Arts Management from the University of Massachusetts.
