

This exhibit continues a nine year tradition at the Edison Arts Society to host an exhibit that features the “Gardens of the Garden State”.

This year, we have designed the exhibit to allow NJ residents to submit work inspired by a garden and created in any medium. The work will be juried at the time of delivery and only those pieces that are accepted will be hung in the Edison Municipal Building, 100 Municipal Boulevard, Edison, NJ 08820

#### **Limitations:**

Open to every New Jersey resident, at least 18 years old & EAS interns.

Open to works not previously shown at an EAS venue, other than the Art in the Garden Tour.

Only works that can be hung on walls may be submitted. Sculpture is welcome, but only if hung.

Work must be no smaller than 11”x14” and no larger than 72” in any direction. The EAS will retain 25% of all sales.

Work that is sold in the course of the exhibit, will need to be replaced with a work of comparable size and quality by the artist.

**Any artist whose work needs to be removed before the closing date must speak to Pat Rubin, EAS Gallery Director.**

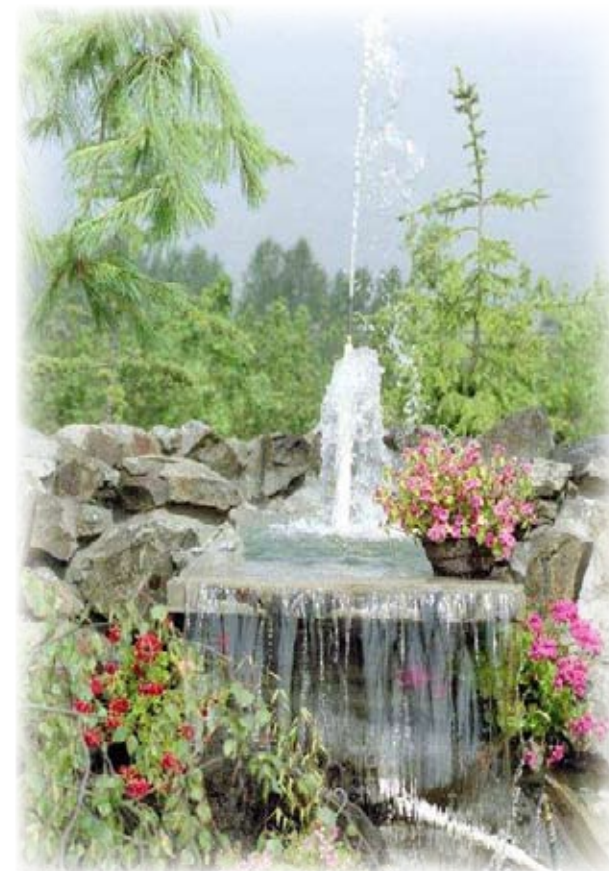
